GENERAL & HOLIDAY VISITATION SCHEDULE
Revised June 2018

The noncustodial parent shall have reasonable visitation rights with the child or children as often as may be mutually agreed. In the absence of an agreement by both parties, the following minimum rights of visitation shall apply in the following priority:

1. WEEKEND: The noncustodial parent shall have the child every other weekend from Friday at 6:00 p.m. until Sunday at 6:00 p.m.
2. SUMMER: The noncustodial parent shall also have visitation rights with the child for two, two-week periods (four weeks total) in the summer. These weeks must be exercised separately so that the custodial parent will not be deprived of contact with the child for more than two weeks unless both parties agree. The noncustodial parent shall notify the custodial parent prior to May 1 of the dates of the weeks chosen for summer visitation. The two-week visitation shall commence on a Friday at 6:00 p.m. and end on a Friday at 6:00 p.m.
3. MARTIN LUTHER KING, JR. HOLIDAY: The Party having the child on the weekend immediately preceding MLK, Jr. Holiday (observed) shall continue to exercise physical custody of the child through MLK, Jr. Holiday (observed) at 6:00 p.m.
4. PRESIDENT'S DAY: The Party having the child on the weekend immediately preceding President's Day (observed) shall continue to exercise physical custody of the child through President's Day (observed) at 6:00 p.m.
5. TELEPHONE: The children shall be permitted to place a reasonable number of phone calls to the noncustodial parent (and to the custodial parent during the noncustodial parent's exercise of his / her visitation rights), and the parent having physical custody of the child's person shall allow the child reasonable access to a telephone for this purpose. The noncustodial parent shall be permitted to place a reasonable number of phone calls to the custodial parent for the purpose of speaking with the child.

The following Holiday Visitation Schedule shall apply unless otherwise agreed upon by the parties:

AGREEMENT: The noncustodial parent shall visit with the child at other such times as many be agreed upon by both parties.

PROMPTNESS: The custodial parent shall have the child ready for these visitation periods at the precise hour enumerated above, and the noncustodial parent shall pick up the child at the precise hour enumerated above. Neither parent shall deviate from this schedule by more than fifteen minutes. The noncustodial parent shall notify the custodial parent at least 24 hours in advance of any decision not to exercise any of the above visitation with the child or of any inability to exchange the child at the precise hour designated for visitation.
